PRIVACY POLICY

This Privacy Policy (hereinafter - the Privacy Policy) applies to all information, located on the domain name https://affstar.com/ (hereinafter - the Website), about the User while using the Website and the services provided by AFFSTAR.

All information about the User while using the Website and the services provided by AFFSTAR is collected by ECOMSTAR SOLUTIONS LTD (Company Number: 14052503), with registered office at: Palliser House, Second floor Palliser Road, W14 9EB London, UK.

This Policy applies where we are acting as a data controller with respect to your personal data and therefore determine the purposes and means of the processing of that personal data.

We take all necessary efforts to ensure that our processing of your personal data meets the standards of UK GDPR/DPA 2018.

1. **DEFINITION OF TERMS**

- 1.1 The following terms are used in this Privacy Policy:
- 1.1.1. Administration of the Website authorized employees to manage the service, acting on behalf of AFFSTAR, who organize and (or) process personal data, and also determine the purposes of processing personal data, the composition of personal data to be processed, actions (operations) performed with personal data.
- 1.1.2. Personal data any information relating directly or indirectly to a defined, or determined individual (subject of personal data).
- 1.1.3. Personal data processing any action (operation) or a set of actions (operations) performed using automation tools or without using such tools with personal data, including collection, recording, systematization, accumulation, storage, clarification (updating, changing), retrieval, use, transfer (distribution, provision, access), depersonalization, blocking, deletion, destruction of personal data.
- 1.1.4. Confidentiality of personal data is a requirement for the Operator or other person who has gained access to personal data to comply with the requirement not to allow their dissemination without the consent of the subject of personal data or the presence of any other legal basis.
- 1.1.5. User of the Website (hereinafter referred to as the User) is a person who has access to the Website and the AFFSTAR Affiliate Network and uses the AFFSTAR Affiliate Network.
- 1.1.6. Services a number of tools to perform marketing services including but not limited providing access to the AFFSTAR Affiliate Network.
- 1.1.7. "Cookies" a small piece of data sent by the web server and stored on the user's computer, which the web client or web browser sends to the web server each time in an HTTP request when trying to open the page of the corresponding site.
- 1.1.8. "IP address" a unique network address of a node in a computer network built over IP.
- 1.1.9. "User" Publisher or Advertiser using the Website or receiving services provided by the AFFSTAR Affiliate Network.

2. GENERAL PROVISIONS

- 2.1. The use of the Website by the User means acceptance of this Privacy Policy and the conditions for processing the User's personal data.
- 2.2. In case of disagreement with the terms of the Privacy Policy, the User must stop using the Website

and AFFSTAR Affiliate Network.

- 2.3. This Privacy Policy applies only to services provided by AFFSTAR. AFFSTAR Affiliate Network does not control and is not responsible for third-party sites to which the User can click on the links available on the Website.
- 2.4. Administration of the Website does not verify the accuracy of personal data provided by the User of the Affstar Affiliate Network.

3. SUBJECT OF PRIVACY POLICY

- 3.1. This Privacy Policy establishes the obligations of the Administration of the Website to not disclose and ensure the regime for protecting the confidentiality of personal data that the User provides at the request of the Administration of the Website when registering on the website.
- 3.2. Personal data authorized for processing under this Privacy Policy is provided by the User by filling out the registration form on the Website in the "Registration" section and includes the following information:
- 3.2.1. email address (e-mail);
- 3.2.2. password;
- 3.2.3. messenger details (Skype, Telegram, other);
- 3.2.4. User's contact phone used to register a Telegram/Skype/other account;
- 3.2.5. payment information.
- 3.3. AFFSTAR protects the following types of data:
- IP address:
- information from cookies;
- information about the browser (or other program that provides access to the display of advertising);
- access time:
- address of the page on which the ad unit is located;
- referrer (address of the previous page).
- 3.4. AFFSTAR collects statistics about the IP addresses of its visitors. This information is used to identify and solve technical problems, to control the legality of financial payments.
- 3.5. Any other personal information not specified above (statistical data, browsers and operating systems used, etc.) is subject to reliable storage and non-distribution, except as provided in paragraphs. 5.2. and 3.6. of this Privacy Policy.

4. OBJECTIVES OF COLLECTING PERSONAL USER INFORMATION

- 4.1. The User's personal data may be used by the Administration of the Website in order to:
- 4.2. Identification of the User registered on the Website for using the services provided by the AFFSTAR Affiliate Network.
- 4.3. Providing the User with access to the services provided by the AFFSTAR Affiliate Network.
- 4.4. Establishing feedback with the User, including sending notifications, requests regarding the use of the Website, providing services, processing requests and applications from the User.
- 4.5. Determining the location of the User to ensure security, prevent fraud.
- 4.6. Confirmations of the accuracy and completeness of personal data provided by the User.
- 4.7. Creation of an account of Advertiser or Publisher for the full use of all services provided by the AFFSTAR Affiliate Network, if the User has agreed to create an account.
- 4.8. Processing payment orders made by the User.
- 4.9. Providing the User with effective customer and technical support in case of problems or questions related to the use of AFFSTAR Affiliate Network.
- 4.10. Providing the User with his consent, updated Services, special offers, pricing information,

newsletters and other information on behalf of the AFFSTAR Affiliate Network or on behalf of the partners of the AFFSTAR Affiliate Network.

4.11. Implementation of promotional activities with the consent of the User.

5. WAYS AND TERMS OF PROCESSING PERSONAL INFORMATION

- 5.1. The processing of the User's personal data is carried out without any time limit, by any legal means, including in personal data information systems using automation tools or without using such tools.
- 5.2. The user agrees that the Administration of the Website has the right to transfer personal data to third parties, in accordance with paragraph No. 5.3. User Agreement.
- 5.3. The User's personal data may be transferred to authorized state bodies only on the grounds and in the manner established by the legislation of which the User is a citizen and in accordance with the legislation of the United Kingdom.
- 5.4. In case of loss or disclosure of personal data, Administration of the Website informs the User about the loss or disclosure of personal data.
- 5.5. Administration of the Website takes the necessary organizational and technical measures to protect the User's personal information from unauthorized or accidental access, destruction, alteration, blocking, copying, distribution, as well as from other illegal actions of third parties.
- 5.6. Administration of the Website together with the User takes all necessary measures to prevent losses or other negative consequences caused by the loss or disclosure of the User's personal data.

6. OBLIGATIONS OF THE PARTIES

- 6.1. The User must:
- 6.1.1. Provide information on personal data necessary to use the AFFSTAR Affiliate Network.
- 6.1.2. Update, supplement the provided information about personal data in case of change of this information.
- 6.2. Administration of the Website is obliged:
- 6.2.1. Use the information received solely for the purposes specified in paragraph 4 of this Privacy Policy.
- 6.2.2. Ensure the storage of confidential information in secret, not to disclose without the prior written permission of the User, and also not to sell, exchange, publish, or disclose in other possible ways the transmitted personal data of the User, with the exception of clauses 5.2. and 5.3. of this Privacy Policy.
- 6.2.3. Take precautions to protect the confidentiality of the User's personal data in accordance with the procedure usually used to protect this kind of information in existing business transactions.
- 6.2.4. To block personal data related to the relevant User from the moment of contacting or requesting the User, or his legal representative or authorized body for the protection of the rights of personal data subjects for the period of verification, in case of revealing inaccurate personal data or illegal actions.

7. COOKIES

- 7.1. The Website use cookies to distinguish you from other users of the Website. This helps us to provide you with a good experience when you browse the Website, to track your online browsing habits on the Internet, allows us to target advertising, which may be interesting to you us and allows us to improve the Website. Detailed information about cookies on the Website you can find in pop-up window when firstly visit the Website.
- 7.2. Most web browsers are set to accept cookies as a default. You may wish to opt out by turning off cookies (please refer to the help menu on your browser).

8. RESPONSIBILITY OF THE PARTIES

- 8.2. In case of loss or disclosure of Confidential Information, the Administration of the Website is not responsible if this confidential information:
- 8.2.1. It became public before its loss or disclosure.
- 8.2.2. It was received from a third party until it was received by the Administration of the Website.
- 8.2.3. It was disclosed with the consent of the User.

9. SETTLEMENT OF DISPUTES

- 9.1. Before applying to the court with a claim for disputes arising from the relationship between the User of the AFFSTAR Affiliate Network and the Administration of the Website, it is mandatory to submit a claim (a written proposal for the voluntary settlement of the dispute).
- 9.2. The recipient of the claim shall notify the claimant in writing of the results of the consideration of the claim within 30 calendar days from the date of receipt of the claim.
- 9.3. All disputes and disagreements that may arise between the AFFSTAR Affiliate Network and the User that will not be resolved on the basis of this Privacy Policy are resolved through negotiations.
- If it is impossible to resolve these disputes through negotiations, they will be considered by the relevant courts of the United Kingdom in accordance with the current legislation of the United Kingdom.
- 9.4. The current legislation of the United Kingdom applies to this Privacy Policy and the relationship between the User and the Administration of the Website.

10. ADDITIONAL TERMS

- 10.1. Administration of the Website has the right to make changes to this Privacy Policy without the consent of the User.
- 11.2. The new Privacy Policy comes into force from the moment it is posted on the Website, unless otherwise provided by the new version of the Privacy Policy.
- 11.3. The current Privacy Policy is available on the Website.
